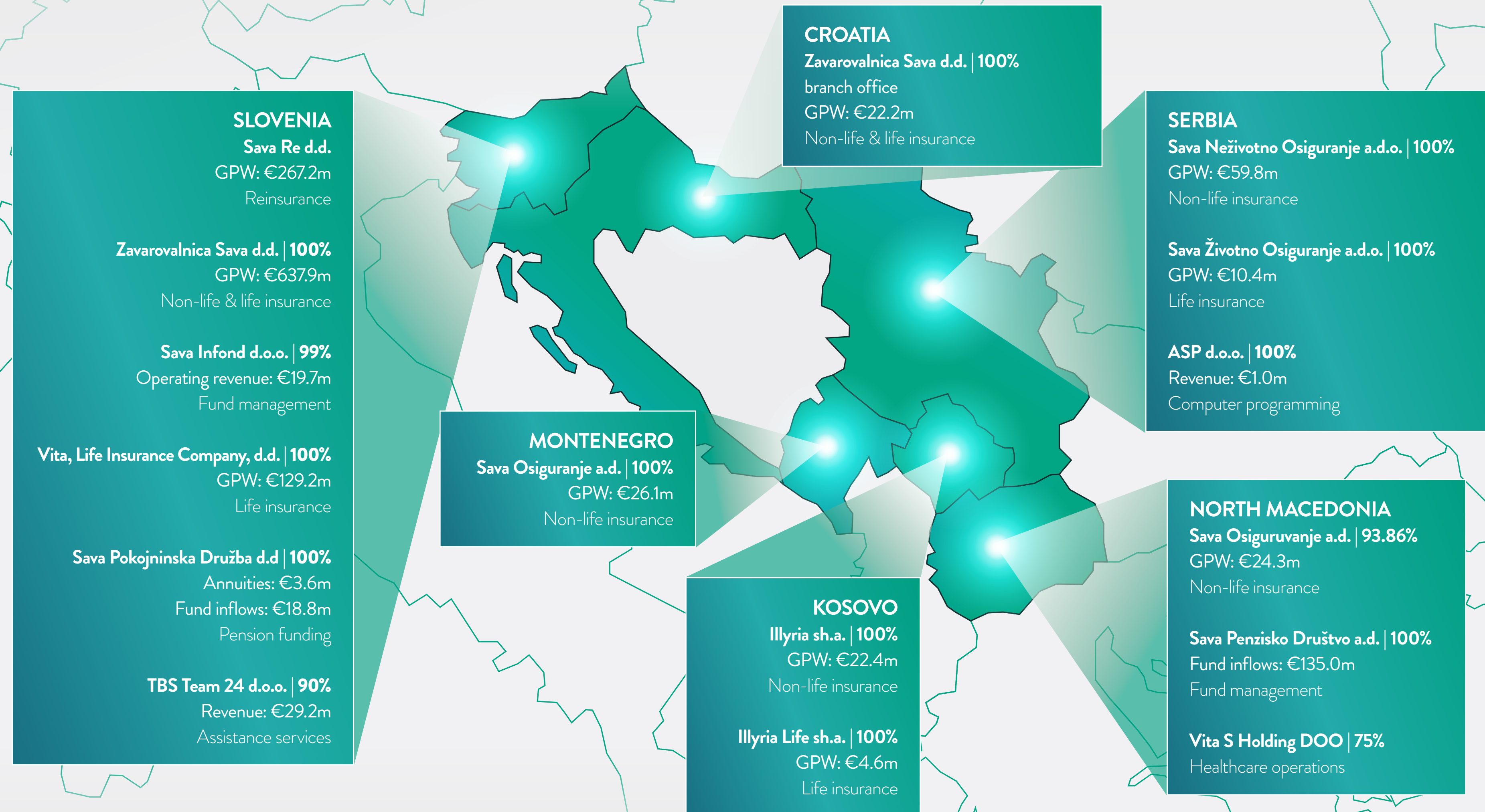

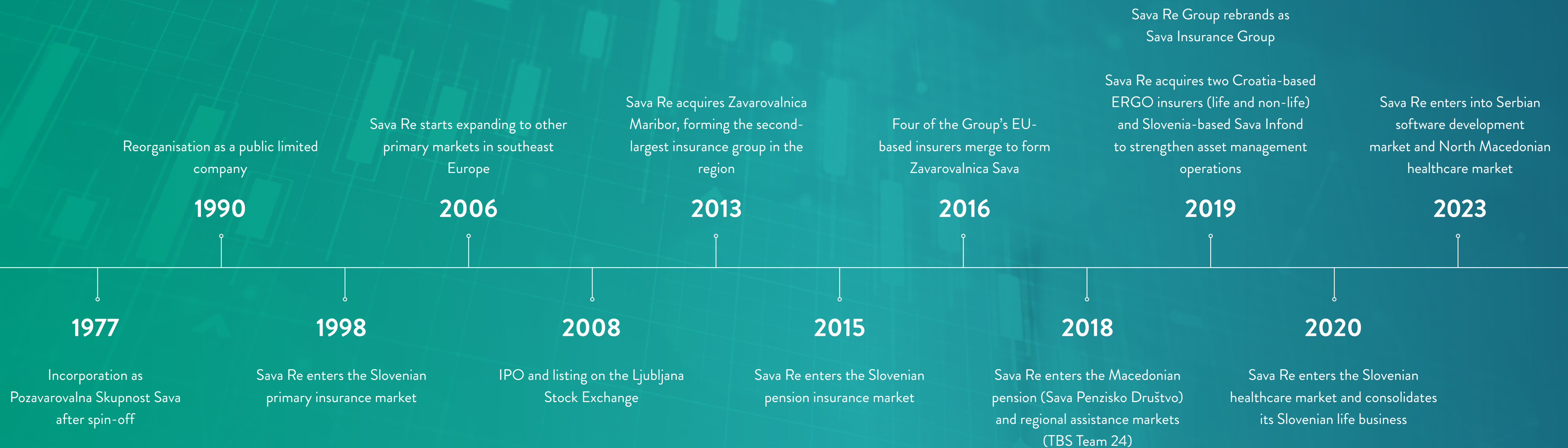
Our services
